John C is attempting to identify all Mohave County roads in the Scenic area that are supposed to be maintained by Mohave County. Roads need to be covered with Road Base rather than just graded.

Sverre Staurset suggested that we take a serious look at updating the 1999 Scenic Master Plan. Several members want to review the current zoning plan (Plot Plan) for our area.

Several members recommended that we make all attempts to (once again) get a member from this area on the Mohave County Planning Commission. Keith Walker and Roger Jacks represent District 1 on the Planning Commission. Both of them live within 25 miles of Kingman. Scenic, Beaver Dam, Desert Springs, and Colorado City does not have a representative on the Planning Commission within 200 miles. SBC members want information on who to contact. We tried this before, but did not get enough support from the Scenic community. Without many contacts to our District Supervisor, nothing will happen.

# Update/Additional Notes:

I (David Abplanalp) failed to bring up the importance of serving on Mohave County Jury Duty. If you are selected for Jury Duty, then please report. You will be paid mileage to and from Kingman at \$.475 per mile. If you are required to stay overnight, the hotel will be set up and paid for by the clerk of the court. You will also be paid for some meals, mileage to and from the Hotel; and \$19 per day for court. There are additional amenities from the court, depending on the length of the case. I received a \$300+ check for three days of jury duty. I also received a nice "Thank You" from the Judge asking for encouragement for Littlefield residents to serve as jury members.

Photos of suspected illegal dumping on public lands were turned over to 1) Beaver Dam Sherriff's Office; 2) BLM Arizona Strip; 3) Mohave County, Development Services, Code Enforcement; 4) Mohave County E.R.A.C.E. program. All responded with the conclusion that Odyssey Landscaping (and possible others) have been dumping palm fronds and tree branches for ten+ years, behind a locked gate on private property. (The dumping is off of HWY 91 at mile marker 5) The debris is burnt with burn permits from Beaver Dam Fire Department when conditions are favorable.
