Andre explained that the fire district ends at Zion off of Elbow Canyon and that anyone wanting to be part of the district would not pay anymore than 3.25 per 100 on there taxes. Damon explained that the Beaver Dam Littlefield Fire Department would respond to all homes and property inside the response area but if the incident was outside the district the property owner would be charged for the Fire Districts services Damon also explained the FDAT tax was given to all fire departments in Arizona so that all residence would not be charged if the fire department responded to an accident that the resident was involved in. Andre stated that in order to become part of the district we would need to get 51% of the people to sign up. It was also said that we would need to be organized by going street by street rather then jumping all around.

6- NEW BUSINESS

- (a) Recycling Bins: Steve Staurset said he put a call into the Virgin Valley Disposal and has not received a call back yet.
- (b) Mercy Air Flight Insurance: Captain Damon Jackson brought in some Boucher's that explained the Mercy air flight insurance and explained that in a critical call like Stroke, Cardiac or serious car accident that the fire department uses Mercy Air as a way to provide advanced life support and to get the patient to definitive care as quickly as possible.
- (c) CPR Classes: The Beaver Dam Fire Department offers CPR classes at \$35.00 plus a \$5.00 card fee Classes can be taught at a 6 student to 1 instructor ratio and will be taught at Station No. 3 in Scenic, AZ.
